**Marriage certificate is issued on the basis of entries in applicant's most recent Indian passport. Therefore, it can only be issued if notarized copies of most recent Indian passport of applicant and spouse with one set of photocopies are sent by mail.**

	<b>Signature of the applicant on all documents should match the signature on their current valid passport</b>
1	Application form Download the <a href="#">Miscellaneous Application Form</a> and fill it up carefully.  Each applicant is required to fill up separate <a href="#">Miscellaneous Application Form</a>
2	Photograph – Passport Size <u>Paste the applicant's photo</u> on the application form/s  PHOTOGRAPH SPECIFICATIONS (Must be white background) <ul style="list-style-type: none"><li>• 2 Photos of size 51mm x 51 mm (2 by 2 size) preferably White Background– PHOTOGRAPHS MUST BE IDENTICAL.</li><li>• Photo must be taken within 6 months.</li><li>• Shoulder must be visible</li><li>• Without glasses</li><li>• Without flashlight reflection</li><li>• With dark coloured attire to distinguish with white background</li><li>• With good lighting on the face</li><li>• Photos must be compliant with specifications.</li></ul> To know more about photo specifications – <a href="#">Please click here</a>
3	Self-Sworn Affidavit – Original and Photocopy Applicant and spouse may separately submit dully signed <a href="#">Self Sworn Marriage Affidavit</a>

4	<p>Copy of Passport – Notarized and Photocopy</p> <p>Applicant and spouse holding Indian passport may provide notarized copy of first and last pages of their passports.</p> <p>Applicants holding passport other than Indian, may submit notarized copy of the current passport held as well as copy of the last Indian passports held</p>
5	<p>Copy of valid US Legal Status – Notarized and Photocopy</p> <p>Notarized copy of documents showing valid US visa status – non-US passport holders</p>
6	<p>Copy of Proof of Address in the USA - Notarized and Photocopy</p> <p>US Driving License or Utility Bill or Lease Agreement or State Identity Card or Mortgage Deed.</p>
7	<p><b><u>Fee:</u></b></p> <p>Consular Fee - \$25.00 per copy, ICWF- \$2.00 and VFS Service Fee \$19.00. Total Fees- \$46.00 per application.</p> <p>The fee can be paid online or through single money order / cashier's cheques, drawn in favour of “VFS Services (USA) Inc”.</p> <p>Note: Personal cheques, personal money orders, and other banking instruments are not accepted.</p>
