	<p><b><u>IMPORTANT GUIDELINES</u></b></p> <ul style="list-style-type: none"> <li>❖ <b>Please ensure that all data entries provided in your application match with your existing passport.</b> If not, please provide the supporting documentation.</li> <li>❖ Please select the correct Indian mission based on the place where you reside in the USA and the mission's jurisdiction. Mission jurisdiction can be viewed at <a href="http://visa.vfsglobal.com/usa/en/ind/attend-centre">http://visa.vfsglobal.com/usa/en/ind/attend-centre</a></li> <li>❖ Online applications are only accepted if filled out in the current year and within 180 days from the date of submission.</li> <li>❖ After submission online, no changes can be made. In case of an error, please fill in a new online application form.</li> <li>❖ <b>VFS INDIA CONSULAR APPLICATION CENTRE employees cannot edit or make any changes to your online application form.</b></li> <li>❖ <b>THE EMBASSY/CONSULATE RESERVES THE RIGHT TO CALL FOR ADDITIONAL DOCUMENTS, AS CONSIDERED NECESSARY.</b></li> <li>❖ If an applicant's occupation is "Journalist", he/she may only apply for a journalist visa, even if you intend to travel for tourism/ business/ medical/ Conference/Employment etc.</li> <li>❖ Visa Application for Pakistani nationals and Pakistan origin USA nationals will take a longer than normal time. USA nationals of Pakistan origin will be required to provide copy of renunciation certificate. Pakistani nationals, including those holding dual nationality should apply for visas on their Pakistani passport only. However, both the passports, in original, are to be submitted; visa will be issued on Pakistani passport and type/duration of visa will be decided by the Embassy/Consulate.</li> </ul> <p><b>It may please be noted that incomplete /erroneous applications will be returned to the applicant for providing the missing/additional documents and re-submission of the full completed application. In certain cases, the Embassy/Consulate may ask for further documentation or call the applicant for an in-person or telephonic interview</b></p>

Minor applicant below 5 years may put left thumb impression on the space provided. Both parents should sign on the last page of the application. Both parents must sign on page 2 of the online application form below the minor's signature/thumb Impression.</i></p>

Photograph must be 2 X 2 Inches on glossy paper showing front view of applicant's face against white background</p> <p><b>Digital Photograph Requirements:</b> Upload a digital photograph Online on Govt. - Size: Minimum 10 KB and Maximum 300 KB
  - The height and width of the Photo must be equal.
  - Photo should present Full face, front view, eyes open and without glasses.
  - Center head within frame and present full head from top of hair to bottom of chin.
  - Background should be plain light colored or white background.
  - No shadows on the face or on the background.
  - Without borders.
  - Make sure that photo presents full head from top of hair to bottom of chin. Head should measure 1 inch to 1-3/8 inches (25mm to 35mm). Make sure eye height is between 1-1/8 inches to 1-3.
  - Incorrect (face downwards or sideways) uploaded photographs will be returned as these applications are considered as ineligible applications. Uploaded photograph face must be upward only.

**FEE PAYMENTS**

Application confirmation letter/ Payment confirmation is mandatory. Complete the process online on VFS INDIA CONSULAR APPLICATION CENTRE's website to get the Application confirmation letter/ Payment confirmation. Don't forget to enclose the Application confirmation receipt. If paying by Money order or Banker's check then it should be made in favor of "VFS Services (USA) Inc. **PERSONAL CHECKS ARE NOT ACCEPTABLE. Ensure you update the correct details of the instrument (Money order/ Banker check. Don't punch dummy information. Incorrect information may lead to rejection of your application)**

**PROOF OF ADDRESS – COPY**

Proof of address must match with the present address as per application: (any ONE of the below documents)

- State Issued ID OR
- Driving license OR
- Utility Bill - Water (should be recent, no more than 3 months old) OR
- Utility Bill - Gas (should be recent, no more than 3 months old) OR
- Utility Bill - Electricity (should be recent, no more than 3 months old) OR
- Valid Lease Agreement OR
- Mortgage OR
- Income Tax return OR
- For College/University Students living on campus in University housing/dormitories, a letter from your institution on the institution letterhead explaining the exact address that you presently reside in will suffice.
- Marriage Certificate in case the address in spouse's name, birth certificate of child in case of minor applicant along with parent's address proof.
- In case of applicants residing with parent's/children/ relatives, a notarized undertaking from them with one of the copies of address proof as indicated above.
- Hotel bill - If the customer on L1/L3 staying in a hotel for a project for the past couple of months and doesn't have the address proof or state ID.

Passport should have minimum validity of six months and must have at least two blank pages.  <u>Note:</u> Holders of dual nationality should apply for visas on their Pakistani passport only. However, both the passports, in original, are to be submitted.</p>

<input type="checkbox"/>	<p><b><u>PROOF OF RENUNCIATION – COPY</u></b>  <b><i>Proof of Renunciation of Indian Citizenship:</i></b></p> <ul style="list-style-type: none"> <li>• If you ever held an Indian Passport, it is MANDATORY to provide proof of the Surrender of Indian Passport along with your VISA application. One of the following MUST be produced as proof: - <ul style="list-style-type: none"> <li>❖ Certificate of Surrender of Indian issued by the Embassy/Consulate of India OR</li> <li>❖ Deemed surrender certificate issued by the Embassy/Consulate of India Both - Cancelled/ Surrendered Passport along with the copy of the Surrender of Indian Passport Certificate would be needed for Indian passports surrendered <b>after May 2010</b></li> </ul> </li> </ul> <p>If you do not have proof of Surrender of Indian Passport then please <a href="#">Apply for Surrender of Indian Passport</a> before submitting the VISA application</p>

Form, their passports and Parental authorization must be identical. Mismatch of signatures will result in delay in application processing or rejected without being processed.</b></li> <li>• Birth certificate of minor applicant – Copy.</li> <li>• Valid Passports and Marriage Certificate of parents – Copy</li> <li>• US visa status documents of non-US national parents – Copy.</li> </ul> <p>If Indian parents do not hold valid US visa status, an explanation for the same may be provided.</p>

<input type="checkbox"/>	<p><b><u>Pakistan-origin USA nationals not holding Pakistani citizenship renunciation certificate/Pakistani passport – ORIGINAL</u></b></p> <p><b><u>If the applicant holds valid National Identity Card for Overseas Pakistani (NICOP) Card or Pakistani National Identity Card (NIC):</u></b></p> <p>Obtain the following additional documents from the applicant:</p> <ul style="list-style-type: none"> <li>Copy of applicant's valid NICOP/NIC Card</li> <li>A notarized self-declaration/affidavit stating that he/she does not hold a Pakistani Passport, but he/she is a dual national of Pakistan holding NIC/NICOP Card and USA passport (As per the <a href="#">Proforma Affidavit</a> attached).</li> </ul> <p style="text-align: center;"><b>OR</b></p> <p><b><u>If the applicant holds Pakistani Visa on foreign passport:</u></b></p> <p>Applicant's previous nationality was Pakistan, but he/she denies having Pakistani Passport and Pakistani citizenship renunciation certificate, obtain following additional documents from the applicant:</p> <ul style="list-style-type: none"> <li>Copy of valid Pak Visa stamped on the foreign passport.</li> <li>Copy of Pak Immigration stamp on the foreign passport.</li> <li>A notarized self-declaration stating the fact that the applicant is not holding dual nationality of Pakistan/Pakistani passport/NIC/NICOP Card (As per the <a href="#">Proforma Affidavit</a> attached).</li> <li>A notarized self-declaration stating the reasons for non-submission of Pakistani Renunciation Certificate.</li> </ul>
